ORDER

Whereas, The All India Radio Co-operative Thrift & Credit Society Ltd., Regd. Add: AIR Co-Operative Thrift & Credit Society Ltd., Akashvani Bhavan, New Delhi-110001, is registered in this office vide registration No. 1576(U) dated 15/12/1956.

And whereas, a request letter dated 30/09/2024 for appointment of Administrator-cum-Returning Officer, has been received from the Executive Members of The All India Radio Radio Co-Operative Thrift & Credit Society Ltd. The tenure of the society was already expired in March 2023.

Whereas Sh. Amresh Chandra Choudhary , AAO had been appointed as Administrator-cum-Returning Officer ,vide this office order dt.25/09/2023. Vide letter dt. 10/07/2024(Page-238/C) Sh. Amresh Chandra Choudhary , AAO has mentioned that the managing committee of the said society has not handed over any record & he has not received any amount from the managing committee.

Now, therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Dr. Rakesh Kumar, ALIO as Administrator-cum-Returning Officer, in The All India Radio Co-Operative Thrift & Credit Society Ltd. under section 35(5) of DCS Act, 2003 to manage the affairs of the society and to conduct the election within a period of 90 days from the date of issue of the order. He is further entitled to receive **Rs. 10,000/- (Rupees Ten Thousand Only)** per month as honorarium and conveyance out of the society funds.

The other expenses of the election will be met out from the fund of the society. The election of Managing Committee of the aforesaid society shall be conducted as per the provision of DCS Act/Rules.


