Whereas, Sh. Amit Kumar Pamasi, DANICS, had been appointed as Administrator-cum-Returning Office, vide this office order dated 06.09.2024. Sh. Amit Kumar Pamasi, DANICS been transferred from Delhi to Dadra and Nagar Haveli and Daman and Diu, vide order dated 12.09.2024, issued by Director (Services), UT, Division, Ministry of Home Affairs, Govt. of India.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri. Dinesh Kumar, Senior Account Officer as Administrator-cum Returning Officer of the Society, in term of section 35(5) of DCS Act, 2003. A sum of **Rs. 10,000/- (Rupees Ten Thousand Only/-)** per month as remuneration plus conveyance allowance will be paid to him from the society's fund.
