And whereas, the last election of the society was held on 28.10.2021. Further, the Management Committee of the society could not conducted the election of the Management Committee till the 28.10.2024. The President of the society informed that the Secretary, Joint Secretary and Treasurer are not available at present to attend the Annual General Body Meeting before 28.10.2024 and tenure of the present Managing Committee expired on 28.10.2024 and the Management Committee of the society lost its mandate to run the society.

Now therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. P. R. Meena, (Retd. IAS) as Administrator-cum- Returning Officer u/s 35(5) of DCS Act 2003 in the Ministry of Works Housing & Supply Cooperative House Building Society Ltd., with immediate effect with direction to conduct elections of the Management Committee of the society within 90 days. He is directed to submit his report after the completion of election to the undersigned positively.

He will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.
