Whereas, Young Aheria CGHS Ltd., Plot No. 02, Sec-07, Dwarka, New Delhi-110075, is registered in this office vide registration No. 833/GH under the provisions of DCS Act/Rules.

And whereas there were 07 members in the Managing Committee of the said society and now there are only 03 members remaining in the MC as 04 members have already resigned from the Managing Committee of the society. As per the by-laws of the society there should be at least 05 members in the Managing Committee of the group housing society but 04 out of 07 members have already resigned from the Managing Committee of the society. Therefore, an Administrator cum Returning is required to be appointed under the provisions of DCS Act 2003 and DCS Rules 2007.s

Now, the competent Authority, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, hereby appoints Sh. Kulanand Joshi, IAS (Retd.) as an Administrator-cum-Returning Officer, in the Young Aheria CGHS Ltd, under section 35(5) of DCS Act, 2003 to manage the affairs of the society and to conduct the election within a period of 90 days from the date of issue of this order. He is further entitled to receive Rs.10,000/- (Rupees Ten Thousand Only) per month as honorarium and conveyance to be paid from the society's funds.
