ORDER

And whereas, Sh. Krishan Kumar, *Special Secretary, PWD, GNCTD* was appointed as Administrator u/s 35(5) of DCS Act 2003 in the Modern Cooperative Group Housing Society Ltd. vide this office order dated 14.06.2024 to with the direction to look after day to day affairs of the society and conduct elections for the new Management Committee of the society.
