**ORDER**

Whereas, Tehsil Alipur Biradari CGHS Ltd., Plot No. 35, Sec-09, Rohini, Delhi-110085, is registered in this office vide registration No. 458/GH under the provisions of DCS Act/Rules.

And whereas as per DCS Act & Rules, the election of Managing Committee of the Society are to be done every three years before the expiry of the tenure of the previous Managing Committee and audit of the books of the society is to be done every year but as per the references received from the society, the said society has failed to follow the DCS Act & Rules. Therefore, for a democratic setup in the society an Administrator cum Returning is urgently required to be appointed.

Now, the competent Authority, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, appoint Sh. Tapan Kumar Jha, Adhoc DANICS/SDM Shahdara, as Administrator-cum-Returning Officer, in the Tehsil Alipur Biradari CGHS Ltd, under section 35(5) of DCS Act, 2003 to manage the affairs of the society and to conduct the election within a period of 90 days from the date of issue of this order. He is further entitled to receive Rs.10,000/- (Rupees Ten Thousand Only) per month as honorarium and conveyance to be paid from the society's funds.
