**ORDER**

Whereas, Airmen and Sailors CGHS Ltd is registered at Regn No.481/GH with this Department under the provisions of DCS Act/Rules & Bye-laws of the society at Plot No. 14, Sector-9, Rohini, Delhi-110085

And whereas, it was brought into knowledge of this department by Sh. Shring Rishi (MS No. 525), Sh. K. Singh (MS No. 13) & Ms. Neera (MS No. 422), all resident of Akash Kunj, Plot No. 14, Sector-9, Rohini, Delhi-110085 through representations dated 20.12.2024 regarding illegal holding of elections in Airmon and Sailors CGHS Ltd (Regn No.481/GH) , Plot No. 14, Sector-9, Rohini, Delhi-110085 and issuance of Agenda by the President of the society.

And whereas, the elections for the Managing Committee of the society was last held on 19/12/2021, the term of which has expired on 18/12/2024. The present MC of the society has not taken timely action for election of new Managing Committee of the society under the provisions of Section 35 of the DCS Act, 2003 and DCS Rules 2007.

And whereas, the President of the society has, of its own, issued circular NO. 08/2024 dated 08/12/2024 prescribing the programme for election of new body on 29/12/2024 in complete violations of set procedure and rules as per DCS Act, 2003 and DCS Rules 2007.

In the above circumstances, Sh. Amresh Chandra Chaudhary, AAO has been appointed as Administrator-cum-Returning Officer by the Competent Authority in Airmen and Sailors CGHS Ltd for conducting the election of Management Committee.

Further, Sh. Amresh Chandra Chaudhary, AAO, the Administrator-cum-Returning Officer is directed to complete the election process in time and as per provisions of DCS Act, 2003 and DCS Rules, 2007 .

Sh. Amresh Chandra Chaudhary, AAO, the Administrator-cum-Returning Officer shall be paid a remuneration of Rs. 10000/-<sup>P.m.</sup> plus other expenses from the society's funds.
