Rakesh Miglani (Owner)that the said guest house building having given an affidavit dated 07.03.2022 regarding not to use any floor above second floor, has deemed complied with the requirement under rule 33 of Delhi Fire Service Rules, 2010 and the building is fit for occupancy Class Residential -A-1, Ground floor (Reception), Mezzanine floor (04 store rooms), 1st floor (04 guest rooms), 2nd floor (05 guest room)total 09 guest rooms up to second floor only, with effect from 01-01-2025— for a period of 03 (Three) years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010.
