Sub: GOVERNMENT POLICY GUIDELINES FOR ISSUE/REVALIDATION OF NOC & ITS ALLIED MATTERS FOR PRIVATELY MANAGED SELF-FINANCED INSTITUTIONS FOR THE ACADEMIC YEAR 2009-10 AND ONWARDS.

Sir/Madam,

I am directed to state that the Government of Delhi has decided to invite applications from institutions for issue/revalidation of NOC and its allied matters, relating to affiliation to GGSIP University etc. for the academic year 2009-10, upto 23.03.2009. They should apply directly to the Registrar, GGSIP University under intimation to the concerned Department of Govt. of NCT of Delhi for revalidation/issue of NOC, as per instructions and guidelines issued vide this office letter No. DHE.4(65)/2007-08/6655-6732 dated 19.03.2008 (copy enclosed).

However, the following amendments/additions in the said policy guidelines are made:-

A. Second shift in permanent campuses (Institutional Area)

- The institutions running from Institutional Area are allowed to run second shift of BBA, BBA(B&I), BBA (T&TM), BBA(CAM), BJMC & BCA courses with the number of students in each section limited to the strength allowed in the morning shift for these courses.
- 2. All such institutions as are permitted to run second shift shall be required to deposit 25% of the fee collected from the students admitted in second shift every year till the course is completed in such scholarship fund as has been prescribed by the Government for providing financial assistance to students from the economically weaker sections of the society.

All other terms and conditions will remain the same as mentioned in letter No. DHE.4(65)/2007-08/6655-6732 dated 19.03.2008.

B. B.Ed. Course.

- 1. The applicant Society/Trust, who is running school on a plot on lease basis, which is not less than 30 years, as notified in the norms of NCTE also, may be considered for issue of NOC for B.Ed. course. The useclassification of such land, will have to be institutional, and appropriate for running the course as per MPD-2021.
- 2. SCERT, an autonomous organization of GNCT of Delhi is according affiliation for ETT / NIT etc. courses in Delhi. Since SCERT is an autonomous organization of Directorate of Education, Govt. of NCT of Delhi, the course of teacher training being run by the said organization may be clubbed with B.Ed. course. The institutions running B.Ed. course and intending to run other teacher training courses such as ETT/NTT etc. may run the said additional courses if they additionally meet the space norms, laid down by the NCTE Jaipur for B.Ed. courses.

C. New Courses

The following new course may be introduced in the Government Colleges /

- Self- financed institutes:-
- 1. BBA (Event Management), 3 Years Degree Course
- 2. BBA (Sports Management), 3 Years Degree Course
- 3. BBA (Creative Visual Art/Designing/Animation), 3 Years Degree Course
- 4. BBA (Office Management), 3 Years Degree Course
- 5. BBA (Fashion Designing), 3 Years Degree Course
- 6. BBA (Hospitality Management), 3 Years Degree Course
- 7. BBA (Interior Designing) 3 Years Degree Course

D. Space Norms.

The covered area of the building in which the course is proposed to be run for the programmes such as BBA & BBA(CAM), BBA(T&TM), BBA(B&I), BCA & BJMC, the institute would be required to have built-up space in the ratio of 4.25 Sq. Meter (all inclusive, per student) instead of 4.5 Sq. Meter as applicable earlier.
