The Officers meeting was held in the Conference Hall of Labour Department under the Chairmanship of the Labour Commissioner on 16<sup>th</sup> January, 2010 (Tuesday) at 10.30 A.M.. The meeting was attended by the officers as per Annexure-I. Different points/ subjects were discussed in detail and the following decisions were taken:-

1. Labour Commissioner reiterated his direction for implementation of Biometric attendance system at Headquarters and district offices. He asked JLC (Admn.) to expedite the same and take appropriate steps in this regard.

**Action: JLC (Admn.)**

2. To facilitate online submission of reports in prescribed format, data card may be provided to all district offices. Labour Commissioner also desired that computerization of South, North West and North district be taken up in 1<sup>st</sup> phase in coordination with DOEACC, NIC and Information Technology Department. Scope of Work for computerization of BOCWW Board, Delhi Labour Welfare Board, Electrical Inspectorate, Factories Inspectorate, Industrial Disputes Act, Workman Compensation Act, Minimum Wages Act be defined in coordination with DOEACC & NIC to create Information Technology enabled environment.

**Action: JLC (Amn.), DLC (South), DLC ( NW), EI**

3. It is informed by Shri Rajinder Dhar, DLC (South) that discussions have been held with DSIIDC and applications relating to Shops & Establishment, Industrial Disputes Act, Factories Act, Electrical / Boiler Inspectorate, cluster mapping of child labour prone areas, DLC's offices on GIS platform would be completed within a month.

**Action: All DLCs**

4. DLCs was asked to enhance the enrollment drive under BOCWW Board in coordination with principal employers and contractors / sub-contractors in coordination with Central Labour Commissioner Office. Registration of construction labourers identified by Education Department and verified by Revenue Department be expedited. Working group be constituted for streamlining collection of cess and working of Board. IEC campaign for dissemination of information on enrollment and benefits be taken up at the earliest.

**Action: JLC-PS, OSD (Board), ALL DLCs**

5. Enrollment under Rashtriya Swasthya Bima Yojna has increased to 2.65 lakhs. IEC campaign be taken for dissemination of information regarding benefits to enrolled beneficiaries and whether construction workers registered under the Board can be extended Rashtriya Swasthya Bima Yojna benefits needs to be explored. It should be ensured that Smart Cards are issued to all beneficiaries and effective rollout of benefits by insurance company and TPA.

**Action: JLC-PS, ALL DLCs**

6. Services Department has informed that Employment Department has proposed to surrender 250 posts along with staff. Joint Labour Commissioner (Admn.) to take up the issue with Additional Director (Employment) for diverting the staff from Employment to Labour Department and working group with Employment Department be formed so that necessary steps on the issue are taken in a time bound manner.

**Action: Additional Director (Emp.)/JLC (Admn.)**
