Sir,

I am directed to inform you that the Govt. of NCT of Delhi has constituted “The Delhi Higher Education Aid Trust” for providing scholarship to the socially & economically backward students of the Universities and its affiliated institutes in Delhi on merit-cum-means basis. Scholarship to the students who are studying in professional courses only, during the Academic Year 2013-14 (other than AICTE approved courses), would be provided through the said Trust.

Scholarship/ reimbursement of half of the tuition fee fixed by the University for professional courses for higher education would be granted to the students whose parental annual income i.e. family income from all sources is upto Rs.2,00,000/-.

Other eligibility conditions are as given below:-

1. The students should have secured 60% marks with no back papers and 70% attendance.
2. The eligible student may apply to the Principal/ Director of the concerned University/ College/ Institute in prescribed format.
3. The concerned University/College/Institute have to constitute a Committee of atleast three Officers at their own level to Scrutinize the applications and the same after scrutiny be submitted to Director/Principal of the said University/College/Institute, who will forward the same with his/her recommendation to the Director, Directorate of Higher Education, Govt. of NCT

of Delhi, 5-Sham Nath Marg, Delhi-110054 alongwith the following attested documents:-

- i) Income Certificate from the concerned Revenue Officer,
- ii) Mark Sheet of the last examination passed (**Academic Year 2013-14**).
- iii) Attendance Record (**Academic Year 2013-14**).
- iv) Fee Receipt (**Academic Year 2013-14**).
- v) Fee Structure of College/ Institute/ University (**Academic Year 2013-14**).

A copy of the format for Scholarship Form and a copy of the attached format are to be filled by the Principal/ Head of the Institute/ University which are enclosed.

The last date for submission of application is 15<sup>th</sup> October,2014 (including by post). No application will be entertained after the prescribed date.
