The premise was inspected by the concern nominated authority of this department in presence of Mr. Sandeep Kumar (Chairman) on 12/02/2020 to verify the compliance of fire prevention and fire safety measures required under the rules. The following shortcomings were observed.

1. Terrace pump of 450 lpm is not auto mode.

2. An overhead water storage tank capacity of 10,000 ltr is found reduced to 4000 ltr.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs.
