Sir,

With reference to your letter No nil dated 20/09/2012 on the above cited subject, this is to inform you that the aforesaid school building have been inspected by the officer concerned of this department in presence of Mirza Furqan Ali, Principal of the School, on 05/03/2013 to verify the fire safety arrangements as per the directives of Education Department vide Circular No. F.16/Estate/CC/Fire Safety/2011/3298-3398 dated 01-03-2011.

During inspection, it was observed that the said school building is comprised of ground + first floor. One staircase of width 0.93 mts found provided in the building. 01 Fire extinguisher of ABC type, electric bell and sand buckets found provided in the building. The following shortcomings were observed:-

a. School Building is not approachable to the fire engines.

b. One additional staircase of minimum 0.75 mts width is required.

c. One ABC type fire extinguisher is required in first floor.

In view of the above shortcomings, 'Fire Safety Certificate' cannot be considered at this stage. You are requested to rectify the shortcomings under intimation to this department.
