
Sir,


The following shortcomings were observed:-

1. Two stairs of 1.5m clear width remotest to each other are not provided.
2. One Exits of 1.2 m clear width remotest to each other are not provided.
3. Two fire extinguishers of ABC type 5kg capacity at each floor are not provided.

In view of the above FSC from fire safety point of view cannot be considered at this stage.

You are requested to comply the shortcomings under intimation with this department for further consideration in the matter.
