This is in reference with your letter No. nil dated 26.05.2020 received in outdoor diary no. O.D. No- O.D. No-5697 dated 08.06.2020, on the subject cited above. The premise was inspected by the concern nominated authority of this department in presence of Smt. Kavita Malik Tomar (Principal) on 14.07.2020 to verify the compliance of fire prevention and fire safety measures required under the rules: following shortcoming has been observed during inspection.

1. Copy of approval drawings of school building may kindly be provided.
2. Terrace doors opening towards stairs in contravention of NBC.
3. Travel distance is more than 45 meter on first floor.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "I" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs.
