The premise was inspected by the concern nominated authority of this department in presence of Shri. S.K.Gupta on 30/09/2019 to verify the compliance of fire prevention and fire safety measures required under the rules. The renewal of FSC is rejected under sub rule (3) of Rule 37, in the view of reasons mentioned below:

- 1. Natural ventilation found covered with Glazing.
- 2. Electrical panel found provided under stair case.
- 3. Exit signage found removed at some place.
- 4. Floor signage in staircase is not provided.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs.
