The premise was inspected by the concern nominated authority of this department in presence of Smt. Murti devi on 08.08.2020 to verify the compliance of fire prevention and fire safety measures required under the rules. The issue of FSC is rejected under sub rule (4) of Rules 35, in the view of reasons mentioned below:

- 1. An overhead water storage tank capacity of 1000 ltr is provided against the required of 2500 ltr
- 2. The required exit signage are not provided.
- 3. Pump found not functional.
- 4. Hose reel found not functional.
- 5. Channel gate are provided at final exit & each corridor.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs.
