
This is in reference with your letter No. nil dated July 2020 received in outdoor diary no. OD no.6685 Dated 17.08.2020 on the subject cited above. The premise was inspected by the concern nominated authority of this department in presence of Mr. Ashok Dabas (Estate Manager) on 15.09.2020 to verify the compliance of fire prevention and fire safety measures required under the rules. The renewal of FSC is rejected under sub rule (3) of Rule 37, in the view of reasons mentioned below:

1. Fire fighting system is not in working condition.
2. Floor landing signage's in stair found removed at some staircases.
3. Exit signage found removed at some places.
4. Staircase door of basement is opening in opposite direction as required in NBC-2011.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs.
