

Sub: - Regarding issue of "Fire Safety Certificate" from fire safety point of view in r/o EDMC Primary School, Chand Mohlla Gandhi Nagar, Delhi-93.

Madam,

Please refer to your letter dated 22/02/17 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the school to verify the fire safety arrangements in accordance with the NBC Part IV. Smt. Usha Rani (Teacher) was present at the time of inspection and it was observed that the school building is now comprised of ground plus Two upper floors and have following shortcomings:-

1. The width of second staircase is less than required width of 1.50 m.
2. Only three fire extinguishers provided in place of six.
3. First Aid Hose reels not provided.
4. Fire pump having 450 LPM output at 40 m head not provided.
4. Overhead water tank of 10,000 ltrs.capacity not provided.

In view of above, the fire safety certificate cannot be considered at this stage. You are requested to rectify the above shortcoming under the intimation to this department for further course of action.
