In this regard, it is to inform you that the site was re-inspected by the officer concerned of this department on 24/06/2021 in the presence of Ms. Neelam (Manager) and observed that the shortcomings already communicated by this department vide letter No. F6/DFS/MS/2019/school/ 5820 dated 26/09/2019 (photocopy enclosed) has not been rectified except point no.1.

Hence, the Fire Safety Certificate cannot be considered at this stage. You are requested to rectify the shortcomings under the intimation to this department for further necessary action in this regard.

**Note:** It was also observed during inspection that one basement is also in the school which is closed with brick wall.

**Sub:** - Regarding issue of "Fire Safety Certificate" from fire safety point of view in r/o Bharat Bharti Public School S.F.S. Sector-G, New Kondli, Mayur Vihar Phase-III, Delhi-96.

Sir,

Please refer to your letter BBPS-MV/2019 dated 28/08/19 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the school to verify the fire safety arrangements in accordance with the NBC Part-IV. At the time of inspection Smt. Neelam Vats (Manager) was present and it was observed that the school building is comprised of ground plus three floor (3<sup>rd</sup> floor porta cabin) and have following shortcomings:-

1. At least one of the staircases having width of 1.5 m shall be required.
2. Over head water tank capacity of 5000 liters provided in place of 10,000 liters.
3. Exit signage's not provided.
4. The Porta cabin constructed on the terrace floor should be removed.

In view of above, the fire safety certificate cannot be considered at this stage. You are requested to rectify the above shortcoming under the intimation to this department for further course of action.
