With reference to your letter dated 05/10/2020 on the subject cited above, it is informed that officer concerned of this department inspected the school from fire safety point of view in presence of Ms. Deepanjali, Principal of the School on dated 19//11/2020. The School building comprises of ground plus two upper floors. During the course of inspection following observations were made:-

- 1. A fire pump with 450 liters per minute discharge at 40 meters head (4kgf/sq.cm.) is required to be provided at terrace level.
- 2. An overhead water tank having 10,000 liters is required to be provided exclusively for fire fighting systems.
- 3. Staircase of width 1.50 meter is required to be provided in the building.
- 4. Sanctioned/as built plan showing fire fighting arrangements by registered architect to be submitted.
