

In view of the above FSC from fire safety point of view cannot be considered at this stage.



This is in reference to your letter no. SKV/PV/ND/2018/1439 dated 5.2.2018 on the subject cited above. In this connection, it is to inform you that above said school building have been inspected by the officer concerned of this department on 6.4.2018 in presence of Mrs. Pramila Varshnaya (HOS) & Sh. Gajraj Singh (Estate manager) to see workability of fire fighting system provided therein.

During the course of inspection following shortcomings have been observed:

1. Fire pump at terrace level is provided but not operational.
2. Water storage tank for firefighting at terrace level found empty.

In view of the above mentioned shortcoming fire safety certificate cannot be granted at this stage. You are advised to rectify above shortcomings under intimation to this department for taking further necessary action.
