This is in reference with your letter No. LSMS-20/2019 dated 19.11.2019 received in outdoor diary no. O.D No. 25546 dated 19.11.2019, on the subject cited above. The premise was inspected by the concern nominated authority of this department in presence of Smt. Parmila Gautam (Principal) on 16.01.2020 to verify the compliance of fire prevention and fire safety measures required under the rules. Following shortcoming has been observed during inspection.

- 1. The width of Staircase is 1.51 & 1.37 mtr against the required width of 1.50 mtr.
- 2. The width of door is 0.83 mtr against the required width of one mtr.
- 3. 3000 ltrs Over Head water captive tank provided against the required capacity of 10,000 ltrs.
- 4. The required exit signage are not provided.
- 5. MOEFA is not provided in all exits.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "I" along with a certificate from Architect/ owner that all the fire prevention and fire safety measures are provided as per Rule 33 of DFS Act-2007/ Rules 2010 in the building/premise & duly filled Performa enclose herewith.
