Sir/Madam,

This has reference to your Letter No. Nil dated 20.11.2016 on the subject cited above. In this connection, it is to inform you that the inspection of above said school building has been carried out by officer concerned of this department on 20.12.2016 to see the compliance of the requisite fire safety measures as per Delhi Fire Service Rules 2010. Smt. Neetu (Teacher) was present at the time of inspection.

During the course of inspection it was observed that school building comprised of ground floor plus two upper floors of a four storied building. The upper floors are served by two staircases having width 77 & 122 cms. The building is approachable to the fire fighting vehicles. The electrical wiring was seen concealed and the electric supply was passing through MCB's. The following shortcomings were observed:-

1. The upper floors are served by two staircases having width 77 & 122 cms, against required width of 150 cms and 75 cms.

2. Door width in each class room is 96 cms against required 100 cms.

3. One CO₂ type Fire Extinguishers of 4.5 kg/2.2 kg capacity each and five ABC type Fire Extinguishers of 04 kg capacity each or WCO₂ type Fire Extinguishers of capacity 09 ltrs each are not provided.

4. Hose Reel System not provided.

5. Terrace fire pump having capacity 450 LPM not provided.

6. Over head water storage tank having capacity 10000 ltrs. not provided.

7. Exit signs not provided.

You are advised to rectify the above-mentioned shortcomings for taking further action as necessary for grant of Fire Safety Certificate.
