Sir,

With reference to your letter No. nil dated 03-12-2015 on the above cited subject, it is to inform you that the aforesaid school building have been inspected by the officer concerned of this department on 10.12.2015 in your presence to check the fire safety arrangements in the school building.

During inspection, it has been observed that the said school building was granted Fire Safety Certificate by this department vide letter no. F.6/DFS/MS/School/2012/4844 dated 31.12.2012 for ground floor (Block-1 & Block-2). But now the management has constructed one more block comprised of ground plus two upper floors served by 02 staircase having width 1.45 mts. & 1.50 mts.. The following fire safety & means of escape arrangements are required: -

- 1. Overhead water tank capacity 10,000 liters.
- 2. Hose reel at each floor.
- 3. Terrace pump capacity 450 LPM.
- 4. Exit signages at places mentioned during inspection.
- 5. Fire extinguishers at places mentioned during inspection.

In view of the above, 'Fire Safety Certificate' cannot be granted at this stage. You are requested to rectify the shortcomings under intimation to this department for taking further action as necessary for issuance of fire safety certificate.
