The premise was inspected by the concern nominated authority of this department in presence of Smt. Dr. Anita Vats on 31.07.2020 to verify the compliance of fire prevention and fire safety measures required under the rules. Following shortcoming has been observed during inspection.

- 1. Terrace floor door found opening in wards in contravention NBC/UBBL. & found welded and locked.
- 2. Pumping arrangement and tanks could not be checked at time of inspection.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs.
