

Sir/Madam,

This is in reference to your letter No. SKV/MN/111 dated 16/04/2019 received in this department outdoor dairy No. 9453 dated 16/04/2019 on the subject cited above. In this connection, it is to inform you that school premise have been visited by officer concerned of this department on 03/08/2019 in the presence of Mr. R. Mathur (Estate Manager) to verify the compliance of fire prevention and fire safety measures required under the rules. During the inspection, it was observed that there are material changes in the building as additions/alterations have been made in the building/premises affecting the fire prevention and fire safety measures including the means of escape. Two additional building blocks of ground plus three upper floors (G+3) and ground plus two upper floors (G+2) have been constructed with in the school premises, both old and new blocks are interconnected. Previously, the school building comprised of ground plus two upper floors only was issued fire safety certificate by this department vide letter No. F.6/DFS/MS/SZ/School/2015/SZ/254 dated 24/02/2015. Thus to adjudge the applicability of fire prevention & fire safety measures, the following documents/information are required to be provided.

1. Sanctioned / Completion plan of the building.
2. As build plan of the building, if sanctioned/completion plan is not available.

In view of above, issuance of Fire Safety Certificate cannot be considered at this stage. You are requested to submit required documents/information for further action in this matter.
