The renewal of FSC is rejected under sub rule (3) of Rule 37, in the view of reasons mentioned below:


1. One staircase found removed in basement.
2. Fire pump was not in working condition at the time of inspection.
3. Height verification from North MCD be submitted in letter department for further consideration

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs.
