Please refer to your letter No. Nil dated 26/12/2019 on the subject noted above, in this connection it is to inform you that the said premises was visited by the officer concerned of this department on 17/01/2020 in the presence of Sh. Sunil Dhaka and observed that building comprised of Ground & 1st Floor only. Fire safety arrangements such as Fire Extinguishers, Hose Reel Hose, Fire Pump & Over Head Tank were found provided.

The following shortcomings were observed during the time of inspection:-

1. Hose Reel hose provided but found nonfunctional / broken.
2. Fire pumps provided but found nonfunctional / damaged.
3. Overhead tank of 2,500 ltr provided but found Broken / Damaged.

In view of above NOC/ FSC cannot be considered at this stage.

You are requested to direct the applicant to rectify above mentioned shortcomings under intimation to this department for further necessary action please.
