During the course of inspection, additional temporary structure (Porta cabin) constructed on the terrace floor was observed in the hospital building. Hence Fire Safety Certificate cannot be renewed at this stage.

You are advised to submit the revised sanctioned building plan on the scale of 1:100 duly marked with fire and life safety system as stipulated in National Building Code of India for further consideration in this matter.
