In this connection, it is to inform you that the inspection of above said school building has been carried out by officer concerned of this department on 14.09.2021 to see the compliance of the requisite fire safety measures. Sh. Chand Ram (Teacher Incharge) was present at the time of inspection. During the course of inspection it was observed that school building comprised of ground floor plus one upper floor and was issued FSC by this department vide letter no.F6/DFS/MS/school/2015/WZ/1714 dated 18.09.2015 for a building of Ground floor. Your request of issue of FSC is rejected as the following shortcomings were observed:-

1. Width of staircase found 1.50 m &1.35 m against required width of 1.50 m each.

You are advised to rectify the above-mentioned shortcomings for taking further action as necessary for renewal of Fire Safety Certificate.
