
Sub: Request for FSC in r/o Sant Parmanand Hospital, Civil Lines.

With reference to the above you have already been informed vide letter no F6/DFS/MS/Hospitals/NDZ/2021/744 dated 31.03.2021 that the plan of the existing hospital building does not match the sanctioned plan cleared by the local body 19.11.1993 (against which fire safety guidelines were issued by this department on 05.03.1993). Therefore, you may route the existing plan of the building (layout, section and elevation plan) in 100: 1 scale through the local building sanctioning authority for any further consideration from fire safety point of view by this department.

This department does not entertain addition/ alteration cases directly unless referred to this department through a local body.
