This is in reference to your letter no. Email dated 06/07/2021 on the subject cited above. In this connection it is to inform to you that the above said residential building has been inspected by the officer concerned of this department on 09/07/2021.

During the course of inspection followings shortcoming have been observed:-

1. Fire check door are found not provided.
2. The Passage to 2<sup>nd</sup> staircase must be free from any obstruction / Lock & key.
3. Ventilation system found ineffective/ nonfunctional.
4. Hose Reels System & Hydrant Found nonfunctional.
5. CO detectors are found not provided.
6. MOEFA found nonfunctional.
7. PA system found nonfunctional.
8. Internal Hydrants found nonfunctional.
9. Terrace fire pumps are found nonfunctional.
10. Apart from this the reply of letter no F6/DFS/MS/2021/GH/50 dated 13/01/2021 is not given till now.

In view of the above, fire safety certificate cannot be renewed. You are advised to rectify the said shortcomings under intimation to this department for taking further necessary action.
