Sub:- Regarding Issuance Fire Safety Certificate.

Sir.

This is in reference to your letter no. nil dated 29/05/17 on the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned EDMC Primary School from fire safety point of view in presence of Mrs. Meera Bai, Principal of the School. During the course of inspection, the following points / shortcomings were noticed in the building comprised of ground plus three upper floors.

- 1. Fire extinguishers were not provided as required.
- 2. First-Aid hose reels (01 nos.) not provided at each floor as required.
- 3. A fire pump having 450 LPM output at 40 meters head not provided at terrace as required.
- 4. Exit Signage were not provided.

In view of above, the building can not be considered for issue of Fire Safety Certificate at this stage. Therefore you are suggested to rectify the above mentioned shortcomings under the intimation to this department for further course of action.
