In this connection, it is to inform you that the premises was inspected by officers concerned of this department on 13/09/2021 in the presence of Sh. Nithesh Lohia (Owner) to check the required fire safety arrangements provided in the building. During inspection, it has been observed that the above restaurant is running at First Floor of a building comprised of Basement + Stilt + Upper Ground + 1st Floor + 2nd Floor. Fire safety arrangements such as Fire Extinguishers, First aid hose reels, Terrace Pump, & Exit signage are provided. However the following shortcomings were observed;-

- 1. Smoke management System is not provided
- 2. Hose Reel Hose of 30 mts length is provided but not functional.
- 3. Automatic Fire Alarm System is provided but not functional.
- 4. Manual Operated Electric Fire Alarm is provided but not functional.
- 5. Automatic Sprinkler System is provided but not functional.
- 6. Hydrant with hose box is not provided.
- 7. Main & stand by pumps of 2280 lpm are not provided.
- 8. Jockey Pump of 180 lpm with 70m head is not provided.
- 9. Under Ground Fire Water Tank of 1, 00,000 ltrs & Overhead water tank of 5000 ltrs capacity are not provided.
- 10. Exit signage not provided.

In view of above Shortcomings, the application for issuance of Fire safety Certificate is not considered at this stage & rejected.
