With reference to your online application No. 2021032511653 dated 31/03/2021 on the subject cited above, it is informed that officer concerned of this department inspected the M/s Haldiram Ethnic Foods Pvt. Ltd. from fire safety point of view in presence of Sh. Mayank, Manager on dated 29/07/2021. The building comprises of ground plus two upper floors (Restaurant running on ground floor and mezzanine floor). During the course of inspection following observations were made:-

- 1. Hose reel, Wet riser/Down comer system to be extended to cover all areas.
- 2. Additional staircase of width 1.50 m is required to be provided at mezzanine floor in the building.
- 3. Alternate exit found blocked.
