Sir,

Please refer to your MHA ID-2019121800982 dated 10/10/2020 on the subject noted above, in this connection, it is to inform you that the said premises was inspected by the officer concerned of this department on 30.11.2020 in the presence of Sh. Ashok (Cook) and observed that outlet is situated on lower ground floor of Worldmark-1 building. Total covered area of the restaurant at the lower ground floor is 108 m² and as per NBC (Part-IV) the no. of occupants comes out to be 55 (99.41/1.8=55.22). Thus capacity of restaurant is 55 persons which is covered under DFS Act 2007, Rules 2010. Subsequently inspection of Eating House is carried out as per NBC (Part-IV) and following shortcoming is observed:-

1. One door of width 1.20 mtr is provided against requirement of 2.00 mtr width & 1.50 mtr width.

In view of above NOC/FSC is rejected under Rule 35 (3) of DFS Act 2007, Rules 2010.

You are requested to rectify above mentioned shortcoming under intimation to this department for further necessary action please.
