Please refer to your letter no. nil dated 06.05.2016 on the subject cited above. In this connection this is to inform you that the above mentioned site was visited by the officer concerned of this department to verify the fire safety measures issued vide Director of Education circular dated 01.03.2011/ NBC Part 4 and observed that the school premise is comprised of newly constructed single block of having ground and three upper floor after demolition of ground floor building on a total plot area measuring 848 sq.m. At the time of inspection Sh. Sanjay kumar Sinha, Teacher was also present at site. During the course of inspection observations/ shortcomings made are as under:-

- 1. Four fire extinguishers provided against the required 06no's of ABC / Co2 type.
- 2. Hose reel hose not provided.
- 3. Pump capacity of 450 LPM with 40 mtr head not provided.
- 4. Exit signage not provided at strategic locations in the building.

Keeping in view of above, fire safety certificate cannot be considered at this stage
