Sir,

This has reference to letter ID No. 2020031704066 dated 25/08/2021 on the subject cited above. In this connection, it is to inform you that the inspection of above said building has been carried out by officers concerned of this department on 21/09/2021 in presence of Sh. Sazy Malik (Manager). During the course of inspection it was observed that the building is comprised of lower ground & upper ground but restaurant is running at lower ground only. The following shortcomings were observed:-

1. Exits of restaurant 1.10 m provided instead of 1.5 m each.
2. First aid hose reel system not provided.
3. Internal hydrant system not provided.
4. Fire Pump having capacity 450 LPM not provided.
5. Over head water storage tank not provided.

In view of above shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk & liability of the owner/occupier. The Licensing Authority/Statutory Authority may take suitable necessary action as deemed fit.
