The following shortcoming was observed during the time of inspection:-

- 1. Entry gate is not accessible for fire tender.
- 2. Width of Corridor in block 2 varies from 130cm to 197cm against required clear width 1.5m.
- 3. LPG cylinders are not being used with proper safety precaution it must be used as per DOE Circular no.3298-3398 dated 01-03-2011.
- 4. Hose Reels found nonfunctional.
- 5. Two Pumps of 450 lpm found nonfunctional.
- 6. Exit signage's not provided.

You are requested to comply the above mentioned shortcomings under intimation to this department for further necessary action.
