This is in reference to your letter no. DND/GH/262/19 dated 10.01.2019 on the subject cited above. In this connection it is to inform you that the above said residential building have been inspected by the officer concerned of this department on 18.2.2019 in presence of Sh. N M Mittal (Member) to check the workability of fire safety systems provided in the building as per fire safety directives issued vide this department letter no. F6/DFS/MS/BP/2017/58 dated 2.3.2017.

During the course of inspection following shortcomings have been observed:-

- 1. Width of roads all around the building for Fire tender movement is 4.80 & 5 Mtrs. at two sides of the building instead of required width 6 Mtrs.
- 2. Width of the staircases is 1.20 Mtrs. at some points instead of required width 1.25 Mtrs.
- 3. One ABC fire extinguisher is provided instead of two at each level in all blocks.
- 4. Exit sign not provided at some places.

In view of the above shortcomings Fire Safety Certificate cannot be granted. You are advised to rectify the above shortcomings under intimation to this department for taking further necessary action.
