Please refer to you: letter No D/5309/DDE/CLZ/2014 dated 07/10/2014 on the subject cited above. In this connection this is to inform you that the inspection of the above said premises was carried out by the officer concerned of this department along with school authority on 14/11/2014 from fire safety point of view and the following shortcomings were observed.

- 1. Three fire extinguishers of ABC type provided against the required 15 no's of ABC / Co2 type. 12 more fire extinguishers ABC / Co2 type shall be provided.
- 2. First-aid hose reel not provided.
- 3. Discharge Pump capacity of 450 LPM with 40 m head not provided.
- 4. Overhead tank capacity of 10,000 ltr not provided.
- 5. Exit Signage Not provided.

In view of the above fire safety certificate cannot be considered at this stage. You are requested to provide the fire safety arrangements as per the NBC Part IV.
