Sir,

This is in reference to your letter no. SBDCGHS/BSES dated 6.8.2019 on the subject cited above. In this connection it is to inform you that the above said residential building has been inspected by the officers concerned of this department on 3.9.2019 in presence of Sh. Shiv Dayal (Secretary) & Sh. M K Gupta (Treasurer) to check the workability of fire safety systems provided therein.

During the course of inspection the following points have been noticed as shortcomings:-

1. Fire Check Door in basement found removed.
2. Sprinkler system in basement found nonfunctional.
3. Fire pump 450 LPM at terrace level is provided but found nonfunctional.
4. Exit signs found removed.

In view of the above shortcomings fire safety Certificate cannot be renewed at this stage. You are advised to rectify the above said shortcomings under intimation to this department for taking further necessary action.
