

This is in reference to your letter no. Email dated 13-07-2021 on the subject cited  
above. In this connection it is to inform to you that the above said residential building has been  
inspected by the officer concerned of this department on 23/07/2021.

During the course of inspection followings shortcoming have been observed:-

1. Ventilation system in basement found nonfunctional.
2. Hydrant & Hose Reels System Found nonfunctional.
3. MOEFA found nonfunctional.
4. Terrace fire pumps are found nonfunctional and not in auto mode.
5. Main valve at terrace found closed. It must be kept open round the clock.
6. Carbon Monoxide detectors and alarm as per standards be installed before 30/09/2021.
7. Fire check Doors at each floor of one hour fire rating must be provided before 30/09/2021.
8. Some rooms are found sealed, on asking hotel staff stated that these room are sealed by DDA.  
Documents explaining the reason must be submitted to this office.

In view of the above, fire safety certificate cannot be renewed. You are advised to rectify the  
said shortcomings under intimation to this department for taking further necessary action.
