1. 02 Exits of 1.5 meter each are not provided.
2. First aid hose reel and hydrant systems are not provided.
3. MOEFA is not provided.
4. Terrace pump of 450 LPM is not provided.
5. Overhead fire water tank of 20,000liter capacity is not provided.
6. Exit signages are not provided (Indequate).

In view of above, Fire Safety Certificate cannot be issued. Therefore, you are requested to rectify the shortcomings for further consideration in the matter.
