The management will be held responsible for any untoward incident for the period if compliance is not made.

Sir/Madam,

This has reference to your Letter No. 1085/2019 dated 26.07.2019 on the subject cited above. In this connection, it is to inform you that the inspection of above said school building has been carried out by officer concerned of this department on 23.08.2019 to see the compliance of the requisite fire safety measures. Smt. Sunita (Vice-Principal) was present at the time of inspection.

During the course of inspection it was observed that school building comprised of ground plus one upper floor and MP hall being used as Auditorium. The upper floor is served by three staircases having width 150 cms each. The building is approachable to fire fighting appliances. The electrical wiring was seen concealed and the electric supply was passing through MCB's. The following shortcoming was observed:-

1. The School is not approachable through gate having width 4.5 meters.
2. Class room door width is 95 cms against required width of 100 cms and door width of Auditorium hall is 180 cms against required width of 200 cms each.
3. Hose reel system for auditorium not provided.
4. Terrace fire pump having capacity 450 LPM not provided for auditorium.
5. Overhead water storage tank of 5,000 ltrs capacity not provided for hose reel system for auditorium.
6. Illuminated exit signs not provided in auditorium.

You are advised to rectify the above-mentioned shortcomings for taking further action as necessary for grant of Fire Safety Certificate.
