Sir,

This has reference to your letter no. 682/Joint/CP/Lic/EH (DA-IX) dated 08.03.2022 on the subject cited above. In this regard, it is to inform you that this department functions under the provisions of Delhi Fire Service Act 2007 and Rules 2010 and issues the Fire Safety Certificate to those buildings /occupancy which are covered under Rules 27 of DFS Rules -2010, only after receipt of reference from local authority concerned. The joint inspection was carried out by officers of this department along with your official on dated 09.02.22 and observed that the this department has not issued FSC (Fire Safety Certificate) to the said Dhaba as on date . However, the detailed report as per record available in the office is as under:

1. The letter was received from Lic. Department vide letter no. 682/Joint/CP/Lic/EH (DA-IX) dated 08.03.2022 and reply was give by this department vide letter no. F6/DFS/MS/GH/NDZ/2019/3014 dated 21 .05.19 (copy enclosed).
2. Again, application was received from applicant on dated 13.07.21 and department asked to applicant to apply thorough online MHA portal for-issuance of FSC to said premises as the MHA has started online portal for issuance /renewal of license of eating house, vide letter no. F6/DFS/MS/GH/NDZ/2021/339 dated 10.08.2021 (copy enclosed).
3. Further, a complaint was received from RWA SIDIPURA addressed to the Commissioner, North, MCD and copy to this department regarding illegally running of restaurant without having valid license. Accordingly, the complaint was forwarded to concerned licensing department /local authority concerned vide letter no F6/DFS/MS/GH/NDZ/2021/426 dated 29 .09.21 (copy enclosed) for taking necessary action at your end.


