Sir,

With reference to Online application no. 2022010200054 dated 02.01.2022 on the subject cited above, it is informed that the guest house was inspected by Assistant Divisional Officer (SPM) from this department on 21.01.2022 in the presence Mr. Kamal Bhatnagar (Manager) and it was observed that building is comprised of **Ground + 03 upper floors : (Ground floor – reception + 18 guest rooms + 1 dormitory, 1<sup>st</sup> floor – 27 guest rooms + 1 dormitory, 2<sup>nd</sup> floor - 32 guest rooms + 2 dormitory, 3<sup>rd</sup> floor – 21 guest rooms + 5 dormitory).** During inspection, following shortcomings were observed: -

1. First Aid hose reels found non functional.
2. Fire check door as required in Gazette Notification dated 27.05.2019 should be provided latest by 31.03.2022.
3. CO detectors with panel and alarm as required in Gazette Notification dated 27.05.2019 should be provided latest by 31.03.2022.
4. The fire pump at terrace should be replaced by fire pump having auto-start mechanism and discharge of 450 lpm with 35 meters head.

In view of above shortcomings, the application for issuance for Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Local Authority/ Statutory Authority may take suitable necessary action as deemed fit.
