Sir,

With reference to your online application No. 20211008173829 dated 14/10/2021 on the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned restaurant from fire safety point of view in presence of Mr. Atul Rana, (Manager). During the course of inspection the following shortcomings were observed.

- 1. One Staircase of 1.50 meters is provided instead of two Staircases of 1.50 mtr each.
- 2. Exit door of 2 mtr &1.50 mtr wide is not provided.
- 3. First Aid Hose reel is not provided.
- 4. MOEFA is not provided.
- 5. Over head tank 8,000 liter provided in place of 20,000 liter as required.
- 6. Exit signage's are not provided.
- 7. Mezzanine floor only have one staircase 1.50 mtr is provided instead of two staircases of 1.50 mtr each.

In view of above, the building can not be considered for issuance of Fire Safety Certificate at this stage. Therefore you are suggested to rectify the above mentioned shortcomings under the intimation to this department for further course of action.
