This is in reference with MHA Portal ID 2021032611705 dated 30-03-2021 on the subject cited above. In this connection, the premises have been inspected by officer concerned of this department on 28/06/2021 in the presence of Sh. Jagmohan Singh Manager of the Guest House. During the inspection, it was observed that the building comprised of Basement + Ground + 03 Upper Floor + one room. The shortcomings observed are as below;

- First Aid hose reel not working.
- 2. Automatic sprinkler system not working in the basement.
- 3. Terrace level pump capacity 900 LPM not working.
- 4. Overhead tank capacity 5000 ltrs found empty.
- Further, it requested to comply the fire safety provisions under clause 7.31 of UBBL- 2016 in the building on or before 30/09/2021 in compliance to the notification dated 27/05/2019 an as approved and extended the deadline for compliance time limit by the Directorate of Local Bodies, UDD, GNCT of Delhi letter no. F5 (189)/AD/LB/2016/359-374 dated 29.06.2021.

In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.
